# Feature Article – California Open Online Library for Education (<u>www.cool4ed.org</u>)

California's three public higher education systems (the University of California, the California State University, and the California Community Colleges) have collaborated on a project creating an online open educational resources digital library for faculty and students in order to support the discovery and adoption of free and affordable digital textbooks. Established in 2014 and supported by the California legislature along with grant funding from the William and Flora Hewlett and Bill and Melinda Gates Foundations, the California Open Online Library (www.COOL4ed.org) is showcasing selected open textbooks for general education courses which are transferable across the three higher education systems. The project was implemented with faculty collecting, peer-reviewing, curating, publicizing, and cultivating the adoption of open textbooks for high impact, lower division courses. The successful completion of this project showcases over 140 open and free college textbooks for 50 GE courses and includes approximately 400 faculty peer reviews for each open textbook. COOL4Ed.org catalogs these open textbooks and the peer reviews so that faculty can easily locate and review their peers' feedback of these open course materials. The CSU has facilitated this project, and MERLOT partners such as Excelsior College and Southern University are using the COOL4Ed.org template to establish and foster their affordable learning solutions' programs. ### Feature Article – Southern University and MERLOT

The Southern University System (SUS) announces the recent launch of the <u>Southern</u> <u>University Open Online Library for Education</u> (www.SUOL4ed.org), the first of several diverse components of Southern University's Affordable Learning Solutions (AL\$) initiative, created in partnership with California State University (CSU) and MERLOT. Initiated in April 2016, the partnership will enable SUS faculty to conveniently and successfully choose high quality no-cost and low-cost course materials for designing and delivering online courses and online programs, enable SU students to easily and equitably have access to the high quality no-cost and low-cost course materials for their courses, allow SU administrators to easily and accurately measure the savings for students being produced by the SU AL\$ program over time, and measure the benefits for students' learning by having immediate and reliable access to high quality no-cost and low-cost course materials for their courses.

"From the onset, we knew this incredible opportunity to work with a proven and dedicated team of professionals would lend itself to establishing viable and advanced learning and teaching assets for our faculty and students," said SU System President Ray L. Belton. "The SU Online Library for Education opens a pathway to a virtual universe of resources at a critical time in light of our budget challenges," added Belton.

" I am very satisfied with what we have accomplished and envision this project to be very significant to building 21st century eLearning infrastructure for the Southern University System of Louisiana," said professor Moustapha Diack, lead of SUS AL\$ project and chair of the SUBR Doctoral Program in Science/Mathematics Education (SMED), and director, MERLOT Africa Network (MAN). Diack is cofounder, with CSU's Gerry Hanley, Assistant Vice Chancellor, Academic Technology Services, of MAN, a network of more than 42 African higher education institutions.

A key goal of SUOL is inviting and supporting faculty to adopt free and open etextbooks and create ePortfolios for capturing and sharing their adoption process, supporting a staff development program for IT staff and librarians so they are knowledgeable and skilled at supporting faculty and students adopting and using no-cost and low-cost course materials, developing ePortfolio templates that will be customized and branded for HBCUs using MERLOT's Content Builder, and supporting the adoption/adaption of the CSU's quality assurance of instruction program for HBCUs that includes the inclusivity of content and pedagogy.

#### **Fall GRAPE Camp Sessions**

## To become a Peer Reviewer for MERLOT, individuals must be an instructor in an institution of higher education and have:

- Expertise in the scholarship of their field
- Excellence in teaching (currently or in the past)
- Experience in using technology in teaching and learning, and
- Connections to professional organizations in their discipline.

MERLOT has developed training for Peer Reviewers to ensure that they become familiar with MERLOT processes and policies on Peer Review. MERLOT Management conducts GRAPE Camp (Getting Reviewers Accustomed to the Process of Evaluation) to train Peer Reviewers on a regular basis. GRAPE Camp consists of a series of three one-hour workshops online, one per week. In these webinars, participants will:

- Develop an understanding of MERLOT
- Learn how MERLOT evaluates Learning Materials
- Conduct a group review
- Complete an Individual Review
- Learn how to use the Workspace tool, and
- Introduce participants to the Editorial Board of their disciplines.

The webinars include people from a variety of disciplines and are archived so participants can review the material as needed. For information about GRAPE Camp, contact <u>Cathy Swift</u>.

#### **Computer Science Editorial Boards**

MERLOT, working together with IEEE Computer Society volunteers are currently in the process of developing two new Editorial Boards (EB) – one in Computer Science, and the second in Information Technology (IT). These new EBs-in-formation are called Task Forces as they develop editorial board members, grow their respective collections, peer review materials in the collections, and acquire IT and CS MERLOT members from around the world.

The Computer Science EB is being led by Professor Henry Chan of the Hong Kong Polytechnic University, and IT by Professor Edmundo Tovar from the Universidad Politécnica de Madrid. Anyone interested in serving on either of those boards should contact Chan and Tovar. If you're in either of those disciplines, you'll be interested to browse the collections for OERs that you might use in your instruction. The taxonomies for each of the collections have been modeled after the CSAB curricula used by almost every accredited CS and IT undergrad program in the world. CSAB is the lead ABET member society for accreditation of programs in CS, IT, and Software Engineering. Chan and Tovar are working closely with IEEE to promote their boards through a number of IEEE-sponsored events. These include 1) a special issue call for papers on Learning Technologies in IEEE Computer Magazine; 2) a call for papers for a Special Track on Computing Education at the IEEE TALE 2016 (Teaching, Assessment and Learning for Engineering) Conference; and 3) a call for papers on Computing Education and Learning Technologies at the IEEE Computer Society COMPSAC (Computers, Software, and Applications Conference) in Turin, July, 2017. All these have been posted on the MERLOT Computer Science Community portal.

These two Task Forces must fulfill certain criteria to be declared Editorial Boards. With the guidance of Minjuan Wang from San Diego State University, we expect to be able to welcome Chan and Tovar into the community of MERLOT editors this coming semester.

#### **ICT Literacy Project: Year One Report**

In order to be prepared for the workplace and lifelong self-development, today's students need to be able to access, evaluate, use, manage, and communicate information in many formats effectively and responsibility; they need to be information literate.

While technology has become more prevalent, its effective use, particularly in academic and workplace settings, is vastly uneven. Formal instruction by knowledgeable instructors is required. However, those instructors themselves need to be ICT (information and communication technology) literate, and have the administrative infrastructure and support to implement such learning experiences.

The CSU system uses the term "ICT literacy" (in this case, rephrasing it as information *and* communication technology) as the basis for discussion, with the understanding that

information literacy is needed to use technology effectively. Information literacy is linked to information technology, but has a broader base and implication. Information technology skills "enable an individual to use computers, software applications, databases, and other technologies to achieve a wide variety of academic, work-related, and personal goals" (ACRL, 2000, p. 1). Thus, technology is used as a learning and generative tool while information literacy is, in effect, an intellectual framework. To this end, ICT literacy is herein defined as the ability to access, manage, integrate, evaluate, create, communicate information purposefully, knowledgeably, technically, and ethically.

The 2015 general education requirements include ICT literacy elements (information literacy, intellectual inquiry, critical thinking, quantitative reasoning, communication, technology, ethical decision-making, and lifelong learning). Because these requires are so new, most campuses have not expanded beyond requirements of critical thinking, quantitative reasoning, communication; five campuses have addressed ICT literacy, one does not mention research skills, five do not mention technology, and eleven fail to mention technology or research skills.

The California State University (CSU) system's Chancellor's Office realized the need to address information and technology literacy across the 23 campuses in a concerted and coordinated manner. Therefore, they used a faculty-in-residence approach. As the ICT Literacy project manager, I am incorporating the CSU MERLOT repository infrastructure to build up an ICT literacy collection, and working with campus sites to integrate ICT literacy into their curricula. In the process, I work with other Chancellor programs and MERLOT communities to optimize system-wide incorporation of ICT literacy to enhance teaching and learning.

In short, the ICT Literacy Project has as its intent to provide a systematic approach to incorporating ICT literacy into education to ensure that students are ICT literate.

Information and Communication Technology (ICT) literacy is the responsibility and opportunity of the entire educational community. As such, the MERLOT ICT Literacy Project coordinates a variety of campus entities: libraries, IT, academic technology, discipline faculty, faculty development, and student support services. The ICT Literacy Project has several aims:

- To build out the ICT Literacy collection within MERLOT and optimize its access
- To develop an ICT Literacy Editorial Board
- To activate the ICT literacy community
- To provide resources and professional development to facilitate the incorporation of ICT literacy across the curriculum
- To facilitate ICT literacy coordination on higher education campuses
- To partner with other higher education initiatives and other relevant stakeholders
- To expand the international aspect of ICT literacy within MERLOT.

The ICT Literacy portal (<u>http://teachingcommons.cdl.edu/ictliteracy/</u>) provides a central location to help faculty integrate ICT literacy into the curriculum. The home page defines ICT literacy, and links to an introductory online tutorial workshop:

https://contentbuilder.merlot.org/toolkit/html/stitch.php?s=80679667629935 The portal also links to ICT resources such as bookmark collections and subject-specific bibliographies.

To leverage the impact of the ICT Literacy Project, an Editorial Task Force has been established as a peer-review forum and network. Current members include Albert Boekhorst (University of Pretoria), Diego Bonilla (CSU Sac), Allison Carr (CSU SM), Christina Cicchetti (UC Riverside), Tim Green (CSUF), Gillian Hallam (Queensland University of Technology), Colleen Harris-Smith (CSU CI), John Ittelson (CSU MB), and Lynn Lampert (CSUN), If interested in becoming a member or a reviewer, please contact Lesley Farmer.



As for me, the project manager, I am a Professor of Library Media and coordinate CSULB's Teacher Librarianship program. I served on the Association of College and Research Libraries Information Literacy Framework Task Force, and co-chaired the U.S. committee for the UNESCO's 2nd edition of *Overview of Information Literacy Resources Worldwide*. I also write and present frequently on ICT literacy, and have garnered several grants and awards in this area. The ICT Literacy editors and I are eager to work with the academic community to facilitate ICT literacy integration into the curriculum so our students

can be future-ready.

#### Meet the Editors Aly El-Iraki and Eduardo Montero Garcia, Co-Editors Engineering Editorial Board

**Aly El-Iraki** received his B.Sc. and M.Sc. degrees in Marine Engineering and Naval Architecture from Alexandria University, Egypt. He received his Dipl.-Ing. and Ph.D. degrees from the Technical University (TU) Berlin, Germany. He has a long track record

of teaching and research culminating in a professorship in Marine Engineering and Naval Architecture. His area of speciality is dynamics, reliability and computer applications to both fields. He has created an innovative method for calculating all the cut sets of a fuzzy-expressed fault tree. He has also developed a novel method for the systematic application of Mason's Rule in linear control systems. Aly is furthermore interested in developing teaching material that utilizes - without being fixated on - computer support and interactivity. Besides teaching and research, Aly was a co-founder of a start-up company specialized in developing engineering reliability software. He also gave expertise on marine engineering related projects. Aly lives now in Ottawa, Ontario, Canada, and is involved in the supervision and accreditation of schools teaching marine engineering in Canada. Aly is especially active in online teaching with Canadian and American Universities. He taught in different countries of the world and is fluent in 3, soon to be 4, languages.

**Eduardo Montero** received the M.S. degree in industrial engineering, specialised in energy enginee ring, from the Polytechnic University of Madrid, Spain, in 1984 and the Ph. D. degree in energy engineering from the University of Valladolid, Spain, in 1996.

He has been employed in the Department of Electromechanical Engineering at the University of Burgos, Spain, since 1984, holding the position of Associate Professor since 1988. At the University of Burgos he hold the positions of Vice-Dean of External Relations at the Higher Polytechnic School (1989-1994), Vice-Rector of Economics and Planning (1994-1997) and Head of the Department of Electromechanical Engineering (2004-2012).



His academic expertise includes engineering thermodynamics, heat transfer and energy technology. His current research interests are experimental determination of thermodynamic properties of industrial fluid liquids, energy efficiency systems in buildings and new methods and systems for engineering education.

He is also Director of the innovation & teaching group named "Active Learning and elearning in Engineering" at the University of Burgos. Within this group, some contributions on e-learning, active learning and engineering education research projects have been developed. He is also member of the International Steering Committee of the International Network for Engineering Education and Research.

His aim as an editor of the Engineering Editorial Board of MERLOT is to improve the quality and dissemination of the engineering learning materials of the MERLOT digital library. This objective will be reached by means of updating and broadening the range of active reviewers in every engineering discipline, boosting the assignments of review processes and increasing the dissemination activities of MERLOT's engineering learning materials.
